## Background

- $\succ$  In Asian countries, there is an increasing trend of countries implementing the systems of pre-review and online registration for Health Authority(HA)'s review process of drug application.
- $\succ$  In some countries, HAs request the applicants to complete online registrations of administrative and CMC data on API, excipients, and packaging materials, which are needed in advance to get the mentioned pre-review initiated.


## Challenges


 $\succ$  These situations has the potential to complicate the review process and cause delays in the review timeline for drug approval.

### Purpose

From the perspective of early access to patients, in Asian countries, we made a survey on the role and actual operation of pre-review and online registration system, and considered from the view point of review efficiency, transparency and predictability.

## Method

- Survey Methods Using Microsoft Forms, questionnaires were distributed to the subsidiaries of Otsuka in 13 Asian countries in Q4 2022.
- $\succ$  Main Topics of Survey
  - The role of pre-review stage and whether it is conducted prior to a full-scale NDA review
  - The timeline and process of the review from NDA submission to acceptance
  - Online registration system

### **Definition of the terms**

#### ✓ Pre-review

: To conduct a screening review before entering NDA full scale review stage, and in some countries, verification takes place before screening.

#### ✓ Screening

: to evaluate qualification for entry to NDA stage, and

#### ✓Verification


: To check completeness and assess acceptability of application dossiers. If the application has passed Verification, it means the application gets official acceptance by HA.

#### ✓ Official acceptance

: To accept the application for HA's review (Not just receiving the application dossiers from applicants).

## Conclusion

Pre-review system not only confirms the completeness of submitted dossiers, but also serves as crucial step to decide the review path in the subsequent NDA stage, which helps applicants to adapt to the deficiencies and/or designated path in early stage, improving the review efficiency and timeline predictability. Furthermore, online registration systems could facilitate applicants to track the progress of review milestones, while contributing to the transparency of review processes.
